Role of Advocacy

 An advocates role is to act as the biased supporter of Indian women experiencing violence, advocating for their expressed interests, including safe space and other resources to gain control over their lives; to provide expertise founded on women's experiences within justice, social service and medical systems; and to prioritize women's safety and offender accountability in all aspects of advocacy, including maintaining confidentiality.

- Safety
- Need to be financially independent
- Finish School
- No credit in my name, or bad credit
- No available housing
- Don't want to move away from family

- Pay first and last months rent, and security deposit, application fees
- Utilities, deposits
- Get on waiting lists
- Stay with parents/friends/relatives: temporarily while on waiting list
- Fill out applications: Long term care/assisted living/etc.

Working with Tribal Housing Authorities

- Safety and confidentiality are critical
- Training on domestic violence, sexual assault, stalking, human trafficking and MMIW
- Understanding processes, getting on waiting lists
- Develop policies that take into account that s/he may have a poor housing record.
- Prioritize victim/survivors women
